# Impromptu Thoughts on Marconi and Lodge

(Excerpts from ACCP President's Speech – October 2007)



I recently read the book "Thunderstruck" by Erik Larson, a fascinating and engaging read that I highly recommend. If you are not familiar with Erik Larson's books, he writes nonfiction. His stories interweave two historical events that converge. Typically, one line of the story involves a great human achievement—in this case, the invention of wireless communication. The other line of the story involves a great human tragedy, usually a gruesome murderer—in this case, the story of Dr. Hawley Harvey Crippen, a homeopathic physician, who poisoned his overbearing wife. Although the story of Crippen's life and crime is certainly interesting, the story of Guglielmo Marconi and Sir Oliver Lodge spoke to me.



Guglielmo Marconi is credited with "inventing" wireless communication at the turn of the 20<sup>th</sup> century. Marconi won the Nobel Prize in Physics in 1909. The initial wireless systems were used to transmit Morse code communications to and from ships. Before that time, it was impossible to communicate with a boat when it was at sea. Soon Mr. Marconi's "invention"

evolved to audio communication from a single source (radio) ...and then television ... and then phones (interactive wireless communication) ... and now computers. Wireless communication is something we take for granted today. What makes Mr. Marconi's "invention" even more remarkable is that he had no formal instruction in physics. Indeed, he did not attend college (or university). He was a very practical man who relied on his own experimentation to figure things out. He did not believe in the conventional wisdom. Marconi was only 27 years old when he and his colleagues made the first successful transatlantic

wireless transmission. But what Marconi lacked in formal education and experience, he made up for in his tenacity and vision—a tenacity to overcome many obstacles and a vision about the potential commercial applications of wireless communication.

But there is a second character in this story: Sir Oliver Lodge. Oliver Lodge performed the first wireless communication in a public forum in 1894, at least one year before Marconi did so secretly in his backyard in Italy, yet most of us have never heard of him. His experiments laid the groundwork for a number of inventions, including wireless communication. Dr. Lodge was a well-educated man who earned a Bachelor's degree and a Doctor of Science degree, a significant



accomplishment at a time when few went to college. He was appointed Professor of Physics and Mathematics at University College, Liverpool, and he held several leadership positions in scientific societies. He was a true academician, a role model for future generations of physicists and scientists to emulate. But although Lodge's experiments, presentations, and publications helped pave the way for many inventions, he lacked tenacity and vision. Perhaps that's being too critical because, like many academicians, Dr. Lodge had to wear many hats and was involved in many projects. And he was motivated not by profit but rather by the quest for knowledge. Unlike Marconi, he did not have the luxury of (or perhaps the desire to) single-mindedly devote himself to developing wireless technology so that it could be used commercially.

As news of Marconi's work became publicly known, the established scientific community was quick to criticize him. What Marconi proposed to do, transmit signals over a great distance even beyond the horizon, defied the laws of physics! To them, Marconi's claims of success were simply not credible. Like many entrepreneurs, Marconi was intensely secretive about his invention and his experiments. He was not terribly interested in contributing to the greater knowledge of mankind, but rather commercializing his product. Because the scientific community could not replicate his work, they were quick to dismiss him. But as the commercial potential of wireless became apparent, Lodge and other scientists joined the fray in trying to produce better

technologies and introduce their own versions of wireless into the marketplace. Indeed, the work of Lodge and other scientists greatly enhanced knowledge and led to many technological breakthroughs, advances that Marconi and his company were often quick to adopt.

How does this story about Marconi and Lodge relate to clinical pharmacy (you may be asking)? Personally, I believe all great advances need Marconis and Lodges. The Lodges of this world are the intellectuals who systematically approach scientific inquiry and whose primary motivation is to expand our knowledge and understanding. The Marconis can see the societal value of a product or service and know how to commercialize it - market it, sell it, refine it - and ultimately make it an integral part of our everyday lives! The success of a Marconi invariably attracts others, which drives further improvements in quality and/or price. It's capitalism (theoretically) at work. In clinical pharmacy today, we have lots of smart people like Lodge tinkering with new ideas and creating new approaches to problems. Many of these strategies work! They help improve health outcomes, reduce patient suffering, improve quality of life, and (in many cases) lower the overall cost of care. The value of what pharmacists can provide to the health care system is irrefutable. But few Marconis are in clinical pharmacy today, people who understand the potential societal value of clinical pharmacy services and know how to commercialize it so that it ultimately becomes an integral part of our everyday lives. I'll readily admit that I'm more a Lodge than a Marconi. But I suspect (hope) there are a few brave souls – probably young and undaunted by the obstacles of our present day health care system - who are Marconis in our midst.

ACCP should be a home for both Marconis and Lodges. Unlike the infighting between the scientific and commercial communities that characterized the development of wireless, I hope ACCP members will understand the lessons from the past and welcome people with different talents and motivations so that we can make clinical pharmacy services readily available to all patients. Our PRNs are our best vehicles to make this vision of ACCP a reality. Are you a Marconi or a Lodge?
