# President's Column Gary R. Matzke, Pharm.D., FCCP

PRNs: Historical Perspectives with Future Consequences



It has been my extreme pleasure to serve this year as the 29th president of the American College of Clinical Pharmacy. In anticipation of the College's 30th anniversary in 2009, I asked the leadership of each PRN to chronicle the history of their PRN since its inception. For centuries past, humankind has been admonished to share the stories of the past generations with the current ones so that God's faithfulness and humankind's actions would not be lost. Indeed, the most significant of these historical events were recorded and became the Torah and the Old Testament of the Bible. Although I doubt that the history of ACCP's PRNs will have the impact of these two works, I do believe that it is fundamentally important for us to know where we have been and what we have accomplished, who the leaders of the past were, what the leadership characteristics of these early visionaries were, and why those who preceded us took us down those paths. Hopefully, the documentation and publication of these histories will guide the PRNs as they and the College contemplate their respective roles and interrelationships for the next decade of the College's existence.

Currently, the criteria for the formation of a new PRN are essentially the same as when the first ones were founded almost 20 years ago. In the past two decades, there have been many significant changes in the practice of pharmacy, pharmacy education, the clinical research enterprise, and the scope and impact of the College on each of these. Thus, it may be a reasonable time for all ACCP members to consider what the role of the PRNs should be and how they fit into the College. Several potential questions worthy of consideration immediately come to mind:

• Is the current requirement for 50 founding members adequate to support a viable organizational entity?

- Are the current programming opportunities and expectations of PRNs optimal for everyone, or should larger PRNs have more frequent opportunities than smaller ones?
- Should the College consider a subspecialty PRN structure wherein some PRNs are aligned with key entities such as the ambulatory care or critical care PRN?
- Should a PRN remain a subspecialty entity until it reaches a critical mass of members or demonstrates consistent contributions to the College or profession?
- Should PRNs exist for eternity, or should they be put to rest unless defined benchmarks of member growth or activity/contributions are met?
- Should PRNs be able to collect dues to support their mission beyond the College's minimal administrative needs?

There are no preconceived answers to the questions posed above, and I am certain that they are not the only ones that you and other members of the College have contemplated as you considered your role in the College's PRNs. Membership in a PRN provides each person an avenue to connect with others of like interest, share his or her patient care experiences, assist one another in the evaluation and management of unusual or rare clinical cases, and stimulate ideas that may form the hypotheses for future research. Our PRNs can only be essential to one's practice and research considerations if we invest our time and energies in them. Some of our PRNs are doing exceptionally well, whereas others are struggling. Thus, this may be just the right time for a "checkup." These and many other questions are among those that the Board of Regents and PRN leadership will need to address in the coming months as they identify what makes a great PRN great and how the structure and function of those that are struggling can be optimized so that the College enters its 30th year with a sound PRN foundation. I encourage each of you to ponder these questions and share your perspectives with me, as well as the leadership of the College and your PRNs. Together, we must build on our past and forge ahead with vigor, enthusiasm, and commitment to transform the practice and research contributions of pharmacy to society.

#### **PRN History Project**

#### **ACCP Launches Emergency Medicine PRN**

ACCP's Board of Regents has approved the application for an Emergency Medicine PRN. The Board created the new PRN by unanimous vote on August 5, 2008. Emergency Medicine becomes ACCP's 22nd PRN.

The PRN's founding chair is Michael C. Thomas, Pharm.D., BCPS, Clinical Pharmacist, Munson Medical Center, Traverse City, Michigan. In describing the need for a new PRN in the area of Emergency Medicine, Dr. Thomas commented: "There are a growing number of pharmacists who practice primarily in the emergency department (ED). We are faced with diverse issues. Some of these include medication reconciliation, drug/toxicology information, medication safety, prospective/retrospective drug review, medication identification, culture and sensitivity report interpretation with follow-up, assistance with medical and traumatic emergencies, precepting students and residents, and educational efforts with other health care professionals."

The new PRN will conduct its inaugural meeting during ACCP's 2008 Annual Meeting on Monday, October 20, from 6:00 p.m. to 9:00 p.m. in the Skybox Room of the Louisville Marriott Downtown. During the first meeting, PRN members are expected to discuss plans for the coming year, including educational programming, future business meetings and networking forums, and other PRN initiatives.

#### **Adult Medicine**

The Adult Medicine PRN has more than 700 members and represents a diverse group of clinical pharmacists dedicated to advancing clinical practice, teaching, and research. Recent accomplishments of the PRN include conducting a budget survey to solicit input from the membership regarding the use of discretionary funds and a diversity survey to assess the demographics (training/education and practice experience) of our membership. The results of both surveys will be presented at the Annual Meeting in Kentucky.

The Adult Medicine PRN, in collaboration with the Ambulatory Care PRN and the Primary Care Special Interest Group of the European Society of Clinical Pharmacy, has been selected to present a "Transitional Care Across Inpatient and Outpatient Settings" symposium at the International Congress on Clinical Pharmacy in 2009. In addition, the PRN has formed a committee that has begun development of a PRN history paper and poster to be presented at the 2009 Annual Meeting.

The Awards Committee is currently soliciting applicants for the New Investigator Development Award. This \$1000 award will provide an opportunity for a new investigator to present and promote his or her research to the ACCP Adult Medicine PRN.

This award is given to a College member who has made substantial and outstanding contributions to clinical pharmacy practice, showing exceptional leadership in the development of innovative clinical pharmacy services and sustained excellence in providing these services.

#### **Ambulatory Care**

Ambulatory Care remains one of the largest PRNs, and its members are very involved in the profession, ACCP at large, and various PRN committees.

The <u>Advocacy Committee</u> continues to fulfill its many charges related to the dissemination of information regarding advocacy issues important to ACCP's membership. This committee works with ACCP Government and Professional Affairs staff to update the PRN membership regarding Medicare Part D and MTMS. Using the PRN listserve, newsletter, and business meetings, the committee encourages the PRN members to participate in the ACCP Advocates Program and to take an active role in legislative efforts by providing information and direction on how to engage in these activities.

The <u>Budget and Finance Committee</u> is currently building an incentive program to reach out to current ambulatory care residents to increase PRN membership and share the great things that ACCP and the PRN are doing. The PRN will be donating \$3000 to the Frontiers Fund for 2008 and \$400 to support student travel to the 2008 Annual Meeting. The PRN is also very happy to report that its budget remains in very good fiscal shape.

The <u>Communication Committee</u> is pleased to report that the second edition of the "Ambulatory Care New Practitioner Survival Guide/Resource Guide" is now available on the ACCP Web site. For members of the PRN, access to an electronic version is **FREE** (and available on the ACCP Web site within the PRN documents). The survival guide is available for purchase (\$29.95) through the online ACCP Bookstore for all ACCP members who are not Ambulatory Care PRN members. In addition, the Ambulatory Care PRN will present a PRN poster at the 2008 Annual Meeting. Finally, the fall newsletter, including articles on MTM by LeeAnn Causey and June Johnson's sabbatical, will be available in October.

The Education Committee, along with the Cardiology PRN, has planned a joint premeeting symposium titled "Current Topics in Ambulatory Cardiology" for the fall ACCP Annual Meeting in Louisville. The PRN focus session is a joint program with the Pharmacokinetics/ Pharmacodynamics PRN titled "The Science and Practice of Pharmacogenetic Guided Warfarin Dosing." Finally, there will be a presentation for a collaborative program (Adult Medicine PRN, Ambulatory Care PRN, and Primary Care SIG) at the ACCP-ESCP International Congress on Clinical Pharmacy meeting next spring in Orlando, titled "Establishing Transitional Processes of Care Across Inpatient and Outpatient Settings."

The Networking Committee is developing opportunities for PRN members to meet and interact at the Annual Meeting and the ACCP-ESCP International Congress on Clinical Pharmacy. The committee has also been directly involved in recruiting speakers for the Networking Forum to highlight innovative practice models, recognize PRN achievements, and update members about ACCP issues that affect the PRN at large. In addition to identifying and nominating five deserving PRN members for ACCP fellowship status (Nicole Culhane, Eric Jackson, Michael Ernst, Karen Gunning,

and Eric MacLaughlin), the 2008 New Clinical Practitioner Award winner (Andrea Wessell, Pharm.D., BCPS, CDE: Medical University of South Carolina) and the 2008 New Educator Award winner (Maria Pruchnicki, Pharm.D., BCPS: The Ohio State University) will be recognized.

The Nominations Committee has selected applicants for the PRN officer positions of Chair-Elect (Nicole Culhane) and Treasurer (Edith Nutescu). In addition, they have reviewed applications and selected a recipient for the PRN Achievement Award. This award, consisting of an engraved plaque and complimentary meeting registration, will be presented at the fall business meeting in Louisville, Kentucky.

The <u>Research and Scholarship Committee</u> announced a request for applications for the Ambulatory Care PRN grant, and electronic submissions are due September 30, 2008. The instructions, eligibility criteria, and application form are available on the PRN Web site. The committee is currently working to identify a scholarly endeavor for the PRN to undertake.

#### **Delafuente Appointed to Council on Aging**

The Virginia House of Delegates has appointed Jeffrey C. Delafuente to a 4-year term on the Commonwealth Council on Aging. The Council serves in an advisory capacity to Virginia's governor, cabinet, and legislature to promote an efficient, coordinated approach to meet the needs of older Virginians. Dr. Delafuente is Professor and Associate Dean for Professional Education at Virginia Commonwealth University School of Pharmacy.

#### Immunology/Transplantation

In 2007, the federal government declared that solid organ transplantation centers participating in the Medicare program must have a multidisciplinary care team. Nevertheless, the agency refused to require the inclusion of specific professionals, including pharmacists. Instead, the Centers for Medicare and Medicaid Services (CMS) named six areas of expertise that the team must encompass: pharmacology, medicine, nursing, nutrition, social services, and transplant coordination. Thus, the transplant center was left to identify the key members of the team responsible for each specified area of expertise. CMS further explained that it had based its decision on the Organ Procurement and Transplantation Network's (OPTN) already described personnel requirements. However, OPTN policy regarding pharmacists is vague at best. It states that transplant programs should identify one or more pharmacists who will be responsible for providing pharmaceutical care to solid organ transplant recipients. Currently, not every transplant program has a policy describing the clinical transplant pharmacist's role or even that of a transplant pharmacist.

This is the first year that CMS has surveyed transplant centers across the country. CMS has stated that noncompliance with Medicare conditions of participation can lead to termination of the Medicare agreement with a transplant center. During the surveys, CMS met/observed transplant pharmacists at each site and asked about their level of participation on the multidisciplinary organ team(s).

However, the transplant community is still waiting for CMS to make further recommendations on the role of the transplant pharmacist on the multidisciplinary team.

#### What is the Frontiers Fund?

The Frontiers Fund is the name of the ACCP Research Institute's development campaign. Created in 2003, the fund has successfully raised and awarded more than \$1 million in grants and program funding. The Frontiers Fund is the mechanism by which the Research Institute, a section 501(c) (3) nonprofit organization, is able to meet its strategic goals. A gift to the Frontiers Fund is the mechanism by which donors show support of the research agenda of ACCP.

#### What are the Research Institute's overall goals?

- To conceive and drive the research agenda of ACCP.
- To help develop the next generation of clinical pharmacy researchers. The *New* Focused Investigator Training Program for experienced researchers and the *New* Research and Scholarship Academy Programs, which will roll out at the 2008 Annual Meeting, are directed at these goals.
- To help position clinical pharmacist principal investigators so they can generate a substantial portion of the research that guides drug therapy in this country and so they can compete successfully with other health care professionals for research funding.

# Will the Frontiers Fund continue to support investigator development grants, fellowships, traineeships, and mini-sabbaticals in 2009?

The ACCP Research Institute is continuing our commitment to excellence and rigor in education and research while expanding the impact of clinical pharmacy professionals across the entire health care spectrum. We are expanding our mission from a grant funder to a research agenda facilitator. Because of the educational and research participation opportunities available from ACCP, there is an expansion in the number of members who will directly benefit on an annual basis from the Frontiers Fund. Benefits of this transition are as follows:

- Through a commitment to clinical excellence and a dedication to scientific rigor, we are maintaining our promise to the profession.
- Through our FIT Program and other initiatives, we are training the preeminent clinical pharmacy researchers of today and tomorrow to help them secure leadership-level funding for their work.
- Through the PBRN, we are creating opportunities for more qualified clinical pharmacy professionals to have a greater impact on the research discovery process.

#### What is the impact of the Frontiers Fund to date?

The Frontiers Fund has allowed ACCP to significantly expand the scope of support it provides to clinical, translational, and health services (practice) research. It has allowed ACCP to significantly enhance its emphasis on investigator development. Through its Frontiers Fund Career Development Research Awards, the ACCP Research Institute is especially interested in supporting the career development of clinical pharmacy researchers and the creation of a national PBRN.

# Did the Frontiers Fund recently pass the \$1 million mark in donations received?

Yes! Everyone involved with the ACCP Research Institute and the Frontiers Fund is extremely appreciative of the generous contributions already made by many ACCP members and the PRNs. The ACCP Research Institute would like to thank those who donated to the Frontiers Fund in 2007 to reach this important milestone.

#### What has the Frontiers Fund accomplished to date?

We rely heavily on donations to continue our mission of providing funding for basic science and clinical pharmacy services research projects and professional development programs. The Frontiers Fund was launched in 2003 with the theme *Invest Today to Expand Pharmacy's Frontiers*. In just 5 years, gifts to the Frontiers Fund by ACCP members, the PRNs, and others have allowed the Research Institute to support new clinical, translational, and health services research studies with total budgets of more than \$1 million. Research has been completed that would not otherwise have been possible.

# Why is research important to clinical pharmacy and ACCP members?

These are direct quotes from ACCP members participating in a recent survey:


• "The money goes back to ACCP members; if we want to

- truly promote a research agenda, these contributions are a great way to do so."
- "To help further the research base of clinical pharmacy, especially documenting the value of our clinical pharmacy services."
- "Support of scholarship among College members, both new and senior investigators. Also, advancement of clinical pharmacy as an evidence-based discipline."
- "We are members of a personally and financially rewarding health care profession. It should be part of one's professional commitment to support scholarly and research activities that not only benefit our professional interests, but also improve the life and health of our patients."

#### What are Frontiers Fund goals for 2008-2009?

Our first goal is to raise at least \$260,000 in 2008–2009. Help is needed now, as the gifts received in 2008 will support the new research programs to be funded in 2008–2009. Our second goal is to increase the percentage of members who donate from 5.8% to 10%.

In 2006, 618 contributors donated a total of \$91,101. The average individual donation was \$174. In 2007, 513 contributors donated a total of \$104,118. The average individual donation was \$196. As the pie chart below indicates, the majority of contributors 65%, contributed less than \$100 to the Frontiers Fund. Approximately 5.8% of ACCP members contributed to the Frontiers Fund in 2007.



Every gift is important every year! ACCP currently has almost 10,000 members. Last year, the average gift to the Frontiers Fund by individual ACCP members was \$196. If each of our 10,000 members donated even \$50, it would total \$500,000! Just imagine what could be accomplished if each gave \$100 or \$200? This is a perfect example of how much we can accomplish if we pool our resources and work together.

# How much of my donation goes to administrative overhead costs?

Only 15% of the monies raised are allocated to administrative support. This is consistent with, or less than, the costs of similar national fundraising efforts, and it means that 85% of all donations are used to support new clinical pharmacy research.

# I gave last year. Why is annual support critical for success?

Even though you may have invested in the Frontiers Fund last year, it is critically important that we all do so again this year, that we make this an annual occurrence, and that we increase the size of our gift, if possible.

Our 2008 goals are to hire a part-time network director, create a listserve, and begin registering individuals and PBRNs with us. Recruiting for the network director will be announced in September 2008.

As an ACCP member involved in providing clinical pharmacy services, you are invited to join the ACCP PBRN listserve. You will receive updates from the ACCP Research Institute as we prepare to launch our PBRN. The listserve is open to all ACCP members. ACCP members are also invited to fill out the online registry tool. Although registration is not a guarantee your site will be selected as a research site, we are looking to build the pool of candidates and sites interested in working on PBRN issues. The registry and listserve are expected to launch in October 2008.

### Review Criteria for Initial types of ACCP PBRN Research Questions

 Address a major issue with an impact on public health that is relevant to key policy-makers on a national level.

- Make it doable within 1 year, yet simple and elegant in design.
- 3. Make it testable using scientifically rigorous, measurable, hard-objective outcomes (not surrogate measures) that have internal validity.
- Do not allow it to be addressed by any other research methods outside a clinical pharmacy-based PBRN framework.
- 5. Make it relevant to clinical pharmacy and in alignment with the ACCP research agenda.
- Make it align across clinical practice venues and capable of implementation in various practice sites/reproducible in various practice sites.
- 7. Make it interventional rather than observational.



The program is an exclusive service offered to student members as a means to facilitate their curriculum vitae (CV) preparation. ACCP is pleased to offer once again this important benefit to its student members.

As the clinical pharmacy profession continues to see increases in demand for residency positions and in competition for first-rate jobs, it is vital that each student have an effective CV. A well-written CV creates a positive image for future selection committees or employers and distinguishes an individual from the rest of the crowd. As questions have arisen in preparing a CV, our student members have found a review by a seasoned professional extremely valuable.

Beginning September 29, ACCP student members may submit their CV online as a Microsoft Word document and have it randomly assigned to a volunteer ACCP member reviewer. The ACCP reviewer will provide his/her comments and/or edits using the track changes feature in Microsoft Word. Students will receive an e-mail containing feedback from a reviewer within 14 business days.
