### Looking Back on a Year of Accomplishment

It is difficult for me to believe that my year as president of ACCP is coming to a close and that soon I will be, as Bill Kehoe has repeatedly reminded me, a "has-been president." This will be my last column in the *PRN Report* as president!

Together, we have accomplished so much this year, yet there is still important work to be done. This is a critical time for clinical pharmacy as we seek to secure our position as members of the health care delivery team in the rapidly evolving health care system. Throughout the year, my ACCP Report columns have addressed the who and the what related to clinical pharmacists' qualifications and their role as providers of direct patient care within the health care team. Who, indeed, is better able to articulate the who and the diverse characteristics that define the what than members of the 22 ACCP PRNs! And who better to mentor our up-and-coming "shining-star" student, resident, and fellow members than our PRN alums!

As you may recall, one of my main charges to the past StuNet National Advisory Committee pertained to increasing student awareness of, and connection with, the PRNs. My exact charge for the committee was,

Students often express interest in learning more about ACCP's PRNs and how to capitalize on the professional networking and learning opportunities associated with the PRNs. However, many students remain uncertain about how to "connect" with a PRN. The committee is asked to determine how to

best communicate to student members the important information about PRNs and opportunities for student involvement with PRNs.

In response to this charge, the committee requested that ACCP allow each student member to join two PRNs free of charge, a request that was approved by the Board of Regents. I am proud to say that, from June 2010 to June 2012, we had a 33% increase in student PRN membership. I believe that in the future, this response will result in increased growth in—and participation of—students and other trainees in our PRNs. In addition, the committee members wanted the student membership-at-large to have a greater awareness of the PRNs, so they developed the "Students' Guide to the ACCP PRNs," which is now posted on the ACCP Web site at www.accp.com/stunet/prncorner.aspx. If you click this link, you will be taken to the overview page, which provides students some basic information on the ACCP PRN structure, highlights the two free PRNs offer, and explains how the e-mail lists work. Directly below the overview information is a link to the individual PRNs, which provides students information specific to each PRN, including the names of leadership and contacts, activities relevant to students, potential for students to serve on PRN committees, and PRN membership numbers by member type (students, residents, and fellows).

Please use this information to further spread the word that we welcome student participation and have much to offer. As I mentioned in an earlier message, many of the PRNs support the ACCP Travel Awards and/or sponsor their own PRN-specific travel awards. You will be able to read more about this important initiative in other *PRN Report* articles. Some of the PRN-specific awards involve students presenting a poster or presentation at their business meeting and networking forum. Many PRNs have developed subcommittees to address student and resident involvement. This has resulted in student-specific activities at a number of PRN business meetings and networking forums during ACCP's Annual Meeting. As you also know,

your elected PRN leaders have worked closely with ACCP executive staff and your Board of Regents on several initiatives to increase the number of board-certified specialties. We still have much to do as we work to continue to address this important component of the ACCP Strategic Plan.

Let me close by saying that it has been an honor and a privilege to serve as your president this past year. As the founding chair of the CNS PRN and a long-standing member of several other PRNs as well, I have always had a sense of pride and ownership with respect to the PRNs, and it has been breathtaking to watch them evolve and grow on the basis of our professional needs and those of our patients. My heartfelt appreciation goes to all members of the PRN leadership and all the PRN members.

#### **Critical Care PRN**

#### **Update on Specialization**

Efforts to establish critical care pharmacy practice as a recognized specialty by the Board of Pharmacy Specialties (BPS) continue as a result of the collaboration among ACCP, the American Society of Health-System Pharmacists (ASHP), and the American Pharmacists Association (APhA). Following a request by the three organizations, BPS completed its role delineation study (RDS) for critical care pharmacy practice in May of this year and issued a call for petitions for possible consideration for this proposed pharmacy specialty in June.

Over the past several months, the organizations have worked together to develop the formal petition, utilizing the RDS data and a variety of other materials needed to fulfill the criteria for an approvable petition. A petition working group consisting of one member/ practitioner in critical care from each of the three groups, together with consultants hired jointly by the organizations, has prepared the "final draft" of the petition, which will be reviewed for approval by the ACCP Board of Regents at its meeting later this month in Florida. The draft petition was reviewed in September by the boards of ASHP and APhA and was approved by them. Once acted upon by the ACCP Board of Regents, the final petition will be transmitted to BPS before the end of the year for its consideration and decision.

BPS has previously indicated that its response and decision on the petition can be expected during the first quarter of 2013. If the petition is approved, the first examination for certification in the specialty area of critical care pharmacy practice could be available as early as the fall of 2014, although no firm timeline is yet available. We will keep you updated as the process moves forward.

#### **Committee Updates**

The updated guidelines were distributed through the e-mail list in June and are posted on the Critical Care PRN Web site. #### **ACCP Student Membership Grows**

### ACCP's Popular Online Curriculum Vitae Review Program Returns

ACCP's innovative Online Curriculum Vitae Review Service is accepting submissions. This program, which began in 2006, is an exclusive service offered to ACCP student and postgraduate trainee (PGT) members to facilitate their curriculum vitae (CV) preparation. As the clinical pharmacy profession continues to see an increase in demand for internship experiences and residency positions and an increase in competition for first-rate jobs, it is vital that students have a well-written CV. An effective CV can provide a positive image for the future selection of committees or employers and distinguish an individual from the crowd.

Demand for the CV Review Service grew last year as ACCP CV reviewers provided almost 400 students and PGTs valuable professional advice to improve their CVs. To better serve our students and PGTs, ACCP is extending the service to accept CV submission through May 31, 2013. The service will then reopen on August 1, 2013.

Students and PGT members may submit their CVs online as a Microsoft Word document and have them

randomly assigned to a volunteer ACCP member reviewer. The ACCP reviewer will provide his or her comments and suggested edits using the track changes feature of Microsoft Word. Participants will receive an e-mail containing feedback from the reviewer within 14 business days.

### 2013 Focused Investigator Training (FIT) Program

Are you an experienced researcher who has just not yet received that big grant as a principal investigator? Do you have pilot data, and are you ready to submit for larger funding? Through this mentored program, pharmacist faculty take necessary steps toward preparing a K, R, or similar investigator-initiated application for submission to the NIH or other major funding source.

#### **ACCP Washington Update**

### President Obama Signs Law to Address Drug Shortages



On July 9, 2012, President Obama signed into law the Food and Drug Administration Safety and Innovation Act, which included several provisions to minimize the impact of drug shortages on patients.

The law establishes an early notification system that requires drug manufacturers to notify the U.S. Food and Drug Administration (FDA) of production problems or if a product will be discontinued. Failure to comply with the early notification requirement will trigger a letter from the FDA.

The law also states that the FDA may expedite the review of certain applications and expedite inspections that could help mitigate or prevent a shortage and requires the FDA to maintain a publicly available, up-to-date list of drugs in shortage, including the cause and estimated duration of the shortage.

These provisions were passed as part of a larger legislative package that reauthorizes the Prescription Drug User Fee Act (PDUFA), first enacted in 1992, and the Medical Device User Fee Act (MDUFA), first enacted in 2002.

Since their inception, these programs have helped ensure that the FDA receives the necessary funding to allow a more predictable, streamlined process for drug and device review and to reduce overall review and approval time.

The PDUFA reauthorization also establishes a new user fee program for generic drugs and biosimilar biologics and includes provisions intended to help enhance the safety of the drug supply chain in an increasingly globalized market, increase incentives for the development of new antibiotics, renew mechanisms to ensure that children's medicines are appropriately tested and labeled, and expedite the development and review of certain drugs for the treatment of serious or life-threatening diseases and conditions.

### ACCP and the Patient-Centered Primary Care Collaborative

ACCP has reinforced its commitment to the goals of the Patient-Centered Primary Care Collaborative (PCPCC) by joining the PCPCC Executive Committee.

The PCPCC is a 1000-member initiative established in 2006 to advance an effective and efficient health system built on a strong foundation of primary care and the patient-centered medical home (PCMH).

PCPCC members include employers, patients, insurance companies, pharmaceutical companies, and care providers such as physicians, nurses, and clinical pharmacists.

ACCP has been instrumental in advancing the work of the PCPCC Special Interest Group on Medication Management and developing the *Medication Management Resource Guide*. This resource guide provides a framework for integrating comprehensive medication management within the PCMH and reinforces the need for accompanying payment reform

to include payment for comprehensive medication management as an essential professional activity for effective integrated care.

The PCPCC recently launched the second edition of the *Medication Management Resource Guide* that includes new "Guidelines for Practice and Documentation" for PCMH and accountable care organization (ACO) teams seeking to include comprehensive medication management services.

As part of the *Resource Guide* launch, the PCPCC hosted a webinar featuring **Amanda Brummel**, **Pharm.D.** (Director, Ambulatory Clinical Pharmacy Services, Fairview Pharmacy Services). The webinar was moderated by leaders of the Medication Management Taskforce: **Terry McInnis, M.D., MPH** (President, Blue Thorn, Inc.), and Ed Webb, Pharm.D., MPH (ACCP Associate Executive Director).

The PCPCC also released its 2012 review of cost and quality results, providing a comprehensive overview of results and data from academic peer-reviewed studies and industry reports on PCMH initiatives across a variety of payers and health systems.

The launch of the report also included a wellattended briefing for congressional staff, members of the press, and other interested stakeholders held in the Rayburn House Office Building on Capitol Hill.

#### ACCP Urges Medicaid to Include Medication Management in Integrated Care Models

ACCP has called on the Centers for Medicare & Medicaid Services (CMS) to include medication management in proposed integrated care models.

In response to guidance from CMS to state Medicaid on designing and implementing care delivery and payment reforms, ACCP called on the agency to include comprehensive medication management as part of a list of activities identified as key to improving health, improving care, and reducing costs within Medicaid programs.

ACCP, together with the College of Psychiatric and Neurologic Pharmacists (CPNP), wrote to the Director of

the Center for Medicaid and CHIP Services to highlight the importance of including comprehensive medication management services in any integrated care model in order to optimize the use of medications that prevent and control disease by directly linking their use to clinical goals and outcomes in a patient-centered fashion using a team-based primary care approach.

CMS issued the guidance to states as part of the process of implementing the Affordable Care Act. The health care reform law, upheld earlier this year by the Supreme Court, includes a variety of initiatives aimed at moving delivery systems from volume-based, fee-for-service (FFS) reimbursement to integrated care models with financial incentives to improve beneficiary health outcomes.

These initiatives include patient-centered medical/health homes, ACOs, ACO-like models, and other health care delivery and financing models that emphasize person-centered, continuous, coordinated, and comprehensive care.

ACCP's letter to CMS praised the agency for issuing the guidance but urged that it recognize the importance of optimizing medication use as part of the reform process and include comprehensive medication management as a listed activity to achieve the goals of better care, better outcomes, and lower costs.

As health care delivery continues to evolve, it is more vital than ever that we help elect congressional leaders who understand and value the role of the clinical pharmacist as part of a patient-centered, multidisciplinary team.

#### **ACCP-PAC Fundraising Challenge**

The success of the ACCP-PAC depends entirely on the support of ACCP members. Although several PACs represent various segments of the pharmacy profession, ACCP has the only PAC dedicated to advancing the practice of clinical pharmacy.

### 2012-2013 ACCP-ASHP-VCU Congressional Healthcare Policy Fellow Program

The ACCP-ASHP-VCU Congressional Healthcare Policy Fellow program was launched in 2006 under the leadership of Gary R. Matzke, Pharm.D. (VCU School of Pharmacy), Ed Webb, Pharm.D., MPH (ACCP), and Brian Meyer (ASHP). The program was developed to provide active learning in multiple policy environments.

The initial month of the program consists of an orientation curriculum put on by faculty of the VCU and the government affairs staff of ACCP and ASHP. Fellows then spend 1 year on Capitol Hill as part of the staff of a congressional committee or the personal staff of a U.S. senator or representative.

The program provides a unique health care policy learning experience that allows the fellow to make practical contributions to the effective use of scientific and pharmaceutical knowledge in government decision-making.

The fellow is also expected to undertake a wide array of responsibilities in the congressional office that he or she serves, including researching and writing briefs on health care issues, assisting with policy decisions, drafting memoranda, and planning, organizing, and contributing to the management objectives of the office.
