Pharmacy Practice: It Is Time for Performance



on improving the quality of care that patients receive.¹⁻⁴ Many professional associations, payers, government and regulatory bodies, and consumer groups have altered their strategic plans and realigned their actions to address the need for improvements in the safety, effectiveness, patient-centeredness, timeliness, efficiency, and equity with which health care is delivered.² Quality improvement collaboratives have been established within and across professional boundaries, and unique funding mechanisms have been implemented for some professionals (e.g., "pay for performance" efforts to enhance health care quality in almost all of its dimensions).⁵⁻⁸ The purpose of pay for performance systems is to align payment incentives to encourage continuing improvement in a way that will ensure high-quality care for all. One of the pitfalls of this approach is that it tends to emphasize the provision of services rather than care. By this, I mean that the avoidance of illness through the provision of services results in a reduction in the use of these services if one is truly doing a good job. The net result of doing a "good job" thus translates into less income to the health care provider and/or the institution for which they work. In essence, when one truly improves the community's health, there is less—not more—use of products and services; moreover, because institutions bill and receive payment for products and services, the pay for performance financial reimbursement mechanism as currently structured does not give one the incentive to provide the optimization of care. Thus, this model for payment of health care providers, especially of pharmacists who have been predominantly product based, likely needs to be realigned. The recent efforts of the Pharmacist Services Technical Advisory Coalition, a coalition of eight national pharmacist organizations that was founded in 2002 to improve the coding infrastructure to support billing for pharmacists' professional services, provided a foundational mechanism for the transition of pharmacist practice from product oriented to patient oriented. The Current Procedural Terminology codes for pharmacist-

provided medication therapy management services, which

were introduced in 2005, were granted permanent status

effective January 1, 2008.

Many barriers must be overcome to fully enable pharmacists to be more effective practitioners/health care providers. The information and knowledge base of medical and pharmacological sciences is expanding at an everincreasing rate; no longer can we accept an educational process that focuses on the "state of today's art and science." The key to lifelong learning is mastering the processes by which we find, evaluate, and integrate new data into our practice paradigms. The latest study results or medication safety crisis should be considered in historical perspective if we are to counsel our patients appropriately and assist in the management of their health. To make major advances in the health and well-being of our communities and individual patients, we need to master the relational skills that are foundational to building trust and establishing an integrity-based covenant relationship. Transparency in our deliberations and interactions with other health professionals is also essential. It is past time that medicine, nursing, and pharmacy students be engaged in learning together to address the technical, pharmacological, and psychological aspects needed to build the foundation of the health care team. This full range of expertise must be honed during one's career to ensure effective communication with all members of our patients' community-based health care team; in so doing, we can implement the optimal treatment plan and management strategy for each patient. Our collective expertise and energies must be centered on the needs of the patient, and we must strive to effectively and consistently communicate these plans to each of them, thereby providing assistance as they strive to become active participants in their own care.

The explosion of new medical knowledge has prompted reevaluations of the pharmacy curriculum as academicians seek to ensure that students are taught the "-omics" of life. The addition of these new findings, however, must not result in the minimization or exclusion of education regarding the tenets of quality of care, patient safety, communication, leadership, and managerial skills. Pharmacists, as well as other health professionals, must learn to recognize and address the psychological needs of their patients, express their feelings and concerns appropriately, and communicate effectively in multiple patient care settings. Finally, we need to learn how to accept responsibility for our patients' health outcomes, which includes learning how to apologize when things go wrong so that we can maintain a trustworthy relationship with our patients and colleagues. To achieve these goals, pharmacists must enthusiastically facilitate, encourage, advocate for, and provide comprehensive patient-centered care, not services. This mantra is in direct opposition to the protectionism perspective that

some individuals/institutions have justified for anchoring pharmacy practice in the past as a consequence of regulatory prohibitions. In some circles, this has recently been replaced by a new protectionist perspective that is the "we are all 'patient-oriented'" pharmacists. Just because we dispense products to patients or ensure that products are delivered to the nursing station of an institution does not make us patient oriented. Although we talk with patients about topics such as sports, the weather, and community events, these dialogues do not use our professional knowledge and relationship/communication skills to advance the health of our communities or individual patients. These pharmacy services are "product oriented," and in providing the product, the pharmacist has not accepted the responsibility for the outcome of the patient's pharmacotherapy. The College has persistently been a leader in advocating for the transition of the profession from a product orientation to one that, consistently in community, institutional, and emerging settings, assumes the responsibility for the medicationrelated health outcomes of each patient. We must not become apathetic, but rather, we must persevere with the belief that pharmacists can truly make medication therapy safer and more effective in all patient care settings.

Pharmacists are well prepared to address expanding patient needs for medication therapy management but have, in many community environments, been hard-pressed to meet the demands of traditional product-oriented pharmacy services (i.e., dispensing of the product). It is thus extremely encouraging to see Project Destiny, the bold new initiative that has recently been put forth by the tripartite coalition of the American Pharmacists Association, the National Association of Chain Drug Stores, and the National Community Pharmacist Association. Project Destiny is intended to "foster the broad embracing of community pharmacy's healthcare services beyond dispensing medication." Their vision of the future is intricately associated with the transforming concept that pharmacists will demonstrate their value by assisting patients and their providers in the overall management of medications and specific disease-state conditions. Project Destiny has identified mechanisms and processes that support the provision of this clinical and medical management expertise that will be valued by patients, providers, health care funders, and payers and that can be replicable, scalable, and economically viable. Based on the preliminary report from the project team, it is time for all pharmacists to make the transition from a transaction-based, commoditized dispensing model to a relationship-based patient-centric model. This transformation process will not be accomplished overnight, and I applaud the coalition partners' vision and their development of the five-step perspective they anticipate will be required if this transformation is to become a reality by 2017. If each of us engages in the transformation process in our local communities by initiating care plans for patients, contributing to the educational reform of our colleges and schools of pharmacy, and advocating for progressive changes in pharmacy practice acts and provider status through our state and national regulatory agencies, the new vision of patient-centered pharmacy in all patient care settings will become a reality.

PRNs Prepare for Officer Elections

The PRN Election Cycle is upon us. It is time for PRN members to begin the process of determining who will serve as officers in the coming year. If you are interested in serving as a PRN officer or would like to nominate someone, please contact your PRN's chair. A roster of current PRN chairs and their contact information is included in this newsletter. The PRN election process is outlined below:

- The Nominations Committee will consist of at least two individuals who are appointed by the PRN Chair; these individuals may be the PRN's current elected officers. Those who comprise a PRN's Nominations Committee will be ineligible to run for office in that PRN's election that year.
- The Nominations Committee should prepare a slate of candidates. Information relative to the election procedures, a timeline, and a list of expected duties shall be provided to each candidate by the Nominations Committee.
- Whenever possible, there shall be two or three candidates for each office up for election. If only one candidate can be identified, an election will still be held, with voters given the option of identifying a write-in candidate.
 When there are more than three possible candidates, it will be the duty of the PRN's Nominations Committee to make the final selection of candidates for the slate.
- The Nominations Committee will obtain a brief (250-word) biographical sketch or candidate statement from each candidate that shall be included in the ballot.

For the second year in a row, Grant E. Sklar, Pharm.D., BCPS, was awarded a Faculty of Science Teaching Excellence Award.

Ambulatory Care

The Ambulatory Care PRN remains one of the largest PRN, and its members are very involved in the profession, ACCP at-large, and various PRN committees. The Advocacy Committee is currently reviewing information regarding the ACCP Advocacy Agenda for 2008 and the Legislative Action Center in order to develop specific plans for how our PRN can support these efforts through action. The **Budget** and Finance Committee has been developing new ways to increase PRN membership and continue to show our support for ACCP-funded research through donations to the Frontiers Fund. In addition, they have been working in collaboration with the Research and Scholarship Committee to fund the second annual Ambulatory Care PRN research grant, which was awarded to Kevin Fuji, Pharm.D. Fuji was awarded \$2000 for his project titled "Electronic Health Record Adoption in Pharmacy Practice." The Communications Committee is currently surveying the membership about new Listserv use policies regarding job postings and independent research efforts. This committee also is reviewing the Survival Guide (which will be available in July through ACCP), preparing a poster for the 2008 Annual Meeting, and continuing to work on the April PRN newsletter, which will have a complete facelift in style and will feature a new resident/student column. The Education Committee has been very busy planning the programming for the 2008 Annual Meeting. This includes a joint focus session program with the PK/PD PRN on the "Science and Practice of Pharmacogenetic Guided Warfarin Dosing" and a joint premeeting symposium with the Cardiology PRN on "Current Topics in Ambulatory Cardiology." They also collaborated with the Cardiology PRN and the American Society of Hypertension (ASH) to present a joint program at the 2008 Annual ASH meeting. In addition, the committee has started planning for the 2009 International Congress on Clinical Pharmacy meeting in Orlando, FL, where a joint symposium with the Integrated Primary Care section from the European Society of Clinical Pharmacy will be developed.

In addition to finalizing the details for the Business and Networking Forum for the upcoming 2008 Spring Meeting, the Networking Committee is taking a scholarly approach to entertainment and constructing a survey that will be used as a game. The Nominations Committee collected nominations for Fellow of ACCP, the Paul F. Parker Award for Distinguished Service to the Profession, the New Clinical Practitioner Award, the New Educator Award, the New Investigator Award, PRN officers, and the Ambulatory Care PRN Achievement Award. Last year, the PRN worked with transplant specialists from around the country to establish educational standards for pharmacists training in solid organ transplantation. Transplant representatives met with members of the American Society of Health-System Pharmacists (ASHP) and drafted these PGY2 standards, which were then distributed for comments. After final review, these PGY2 standards in transplantation were accepted in October 2007. Currently, there are six PGY2 programs (The University of Utah Hospital and Clinics, Tampa General Hospital, Barnes-Jewish Hospital, New York Presbyterian, University of Illinois, and Methodist University Hospital in Memphis) accredited by the ASHP.

A new Resident/Fellow Travel Award is available in the amount of \$500 for the ACCP Annual Meeting in Louisville, KY, this year. To be eligible for the Travel Award, candidates must currently be members of the Transplant/Immunology PRN; have a research abstract accepted by the Transplant/Immunology specialty section for the fall ACCP meeting; be a resident/fellow at the time the research was conducted; and be willing to present his/her poster as a brief platform talk at the PRN Networking Session to be conducted during the same meeting as the poster is presented. A survey was sent to the members earlier this year for feedback on which option seemed most appropriate for our group. The general consensus was that either option was acceptable; however, several members stated that they would be much more likely to donate through the Frontiers Fund. Only a few members expressed disinterest in restarting the program. It is the current Chair's recommendation that funding through the donations to the Frontiers Fund be pursued. There will be further discussion at the spring ACCP business meeting before a final decision is made.
